The U.S. Department of Transportation (DOT) considers a change in the departure airport to be a "significant schedule change". This classification is critical because it grants you specific rights, even if you purchased a non-refundable ticket, such as Basic Economy.

### 1. The Right to a Full Refund

If United Airlines changes your departure or arrival airport, and the new itinerary is unacceptable to you, you are entitled to a **full refund** back to your original form of payment.
